INSTRUMENT

- The survey was completed on-line from November 14th, 2011 to November 17th, 2011 using Leger Marketing's online panel, LegerWeb, with a sample of 374 Canadians with minor children
- A probability sample of the same size would yield a margin of error of ± 5.1% 19 times out of 20

ONLINE PANEL

- Leger Marketing's online panel has approximately 360,000 members nationally with between 10,000 and 20,000 new members added each month, and has a retention rate of 90%
- Panel members are randomly selected to receive email invitations to the individual surveys
- We ensure the protection of privacy via the usage of unique URLs and respondent IDs in combination with survey IDs


Appointing a guardian

- While the majority of Canadians with children say they have not appointed a guardian, thirty-seven per cent have.
- Regionally, Ontarians (37%), Quebeckers (51%) and those from the Prairies (50%) are more likely than those from BC (15%) to say they have appointed a guardian in their will. Predictably, older age groups (35-54) with children are more likely to say they have appointed a guardian in their will than those 18-34 (46% vs. 19%).




Important factors when choosing a guardian

- When choosing a guardian, parenting skills, financial stability, whether or not they are a member of the family and proximity to other family members are the most important qualities.
- Parenting skills are nearly universally valued to be important, however it is less frequently highlighted in Atlantic Canada (84%). Financial stability assumes particular importance in Ontario (98%) and Alberta (100%). Regionally, Residents of Alberta (66%), British Columbia (49%), and Ontario (43%) are more likely than either Quebeckers (25%) or residents of the Prairies (14%) to say that location is very important. Residents of Quebec are also the least likely to place importance on religious or moral beliefs (39%).

- Only 3 in 10 say choosing a guardian was an easy decision to make.
- Regionally, residents of Quebec are more likely to say the final decision of who to choose to be a guardian was an easy decision compared to parents in BC (41% vs. 15%). Interesting, those who have appointed a guardian are the most likely to say that it was an easy decision to make (56%).




Guardians and executors

• One quarter of Canadian parents say the guardians they have appointed are the same people as the executors of their will. This is especially true of those who have already appointed a guardian (47%). Predictably, older parents (35-64) are more likely to appoint the same people to act as guardians and executors of their will compared to those 18-34 (31% vs. 12%).




Compensating guardians for extra expenses

- The majority of parents do not know how much money they would leave their appointed guardian to compensate them for additional expenses (51%). Only 1 in 5 parents say they would leave \$10K or more to their appointed guardian.
- Those who have appointed a guardian are the most likely to say they will leave more than \$25K to their guardian to help cover extra expenses (20%).




First choice for appointing a guardian

- For half of Canadians, siblings would be the first choice if they were to appoint a guardian, while about one in six would opt for parents or other family members.
- Siblings are a particularly popular choice in Quebec, where 68% percent would elect to appoint them. This is also a popular choice among those who have actually appointed a guardian, with 61% of these individuals indicating that their first choice would be their siblings.




Discussions when appointing a guardian

- A mutual discussion of finances would be the most common discussion when appointing a guardian. More than a third would take the time to discuss extra expenses, and an identical proportion would discuss appropriate compensation for the role.
- Regionally, Ontarians (53%) and British Columbians (53%) are more likely residents of Quebec (29%) to discuss the potential guardian's financial situation, while residents of Quebec (36%), Ontario (38%), and British Columbia (43%) are more likely than Albertans to discuss extra expense that one may occur by accepting this role (16%).




Being asked to be a guardian

- A majority would accept the role of guardian willingly (62%), and virtually no parents with minor children would decline.
- Demographically, there are few notable differences across Canada, however residents of Quebec (79%) exhibit the most willingness to accept the responsibilities of being a guardian.
