Management Discussion of Fund Performance

Results of Operations

The ETF returned 2.91% versus the blended benchmark, which consists of 50% S&P/TSX Capped Composite Index and 50% FTSE TMX Canada Universe Bond Index (the "Index") return of 1.55%. The change in total net asset value during the Period from approximately \$81 million to approximately \$104 million had no impact to the performance of the ETF.

The difference in the performance of the ETF relative to the Index during the Period (1.36%) resulted from the payment of management fees (-0.31%), and the impact of sampling and certain other factors (1.67%), which may have included timing and holding differences with the exposure of the ETF to international markets versus the Index, and market volatility.

Market Conditions

During the Period, Canadian equities, as represented by the S&P/TSX Capped Composite Index, returned approximately 0.7%, underperforming most other developed equity markets. The Canadian dollar was initially among the weakest currencies in the first quarter of 2017, but rebounded in the second quarter, due to stronger growth, to end the Period higher against the U.S. dollar. In May, the Organization of Petroleum Exporting Countries ("OPEC") announced oil production cuts; however, high inventory levels in the U.S. drove the commodity price lower, which fell over 19%.

During the Period, Canadian fixed income markets were up as the Bank of Canada maintained its current interest rate policy. The portfolio manager believes the strong housing market and consumer debt levels weighed heavily on the BoC's decision to not raise interest rates, despite improving economic growth and stabilizing oil prices. Canadian bonds returned approximately 2.4%, as measured by the FTSE TMX Canada Universe Bond Index. Canadian bonds posted positive returns across most maturities and sectors, however, bonds with long-dated maturities generated higher total returns than short-dated bonds. From a sector perspective, Corporate bonds posted returns at approximately 2.9%, Provincial bonds at approximately 3.5% and Federal bonds at approximately 0.9%.

The ETFs exposure to International dividend equities contributed the most to performance, while U.S. dividends and put write strategies detracted the most from performance. Significant individual contributors to performance were BMO International Dividend ETF, and BMO Europe High Dividend Covered Call Hedged to CAD ETF. Individual detractors to performance included exposure to BMO US Dividend ETF and BMO US Put Write ETF.

Recent Developments

The portfolio manager believes that growth in the Canadian economy will continue to strengthen for the remainder of 2017. Stronger global economic growth should help Canadian exports, however, uncertainty in both the housing market and oil prices may present risks to equity growth. The portfolio is well-diversified by region, with exposure to Canadian, U.S., and international yield-oriented equity

portfolios. The portfolio is constructed to collect a higher than market level of dividend, while minimizing risk to the extent possible.

The portfolio manager believes that Canada will remain in a low interest rate environment with little expectation that the Bank of Canada will raise interest rates in the coming period. Meanwhile, interest rates in the U.S. are expected to continue to move higher in the expectation of President Trump's pro-growth tax reform and infrastructure spending; this could raise inflation and government debt levels. Higher interest rates in the U.S. could spill over to other markets as it did in 2016.

The ETF continues to have exposure to both fixed income and equity which provide a balanced approach to overall markets. The ETF invests in asset classes that provide higher than benchmark yield, while mitigating risk. The ETF is positioned to benefit from improving economic conditions, while remaining more defensive than broad equity and fixed income markets should a market correction occur in 2017.

Related Party Transactions

The Manager, an indirect, wholly-owned subsidiary of Bank of Montreal ("BMO"), is the portfolio manager, trustee and promoter of the ETF. From time to time, the Manager may, on behalf of the ETF, enter into transactions or arrangements with or involving other members of BMO Financial Group, or certain other persons or companies that are related or connected to the Manager (each a "Related Party"). The purpose of this section is to provide a brief description of any transactions involving the ETF and a Related Party.

Designated Broker

The Manager has entered into an agreement with BMO Nesbitt Burns Inc., an affiliate of the Manager, to act as designated broker and dealer for distribution of BMO exchange traded funds, on terms and conditions that are comparable to arm's length agreements in the exchange traded funds industry. The material terms and conditions of the agreement have been disclosed in the ETF's prospectus.

The Manager has also entered into agreements with other major dealers in Canada to act as dealers for the creation and redemption of units of BMO exchange traded funds.

Management Fees

The Manager is responsible for the day-to-day management of the business and operations of the ETF. The Manager monitors and evaluates the ETF's performance, manages the portfolio and provides certain administrative services required by the ETF. As compensation for its services, the Manager is entitled to receive a management fee payable quarterly and calculated based on the daily net asset value of the ETF at the maximum annual rate set out in the table below.


Past Performance

⁽⁹⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

⁽⁴⁾ The ETF's portfolio turnover rate indicates how actively the ETF's portfolio manager manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the year. The higher an ETF's portfolio turnover rate in a year, the greater the trading costs payable by the ETF in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of an ETF.
