Sending high dollar value, time sensitive, domestic and international payments is an important part of running your business. Advanced functionality to save you time

- Create templates for recurring payments
- Import wire payment files from your accounting software
- Approve several wires at once
- Save your freeform wires as templates
- Update the wire currency when using an existing template to send the payment as a Foreign Exchange wire if it's going to a foreign destination
- Create an easily accessible shortlist of frequently used beneficiary or intermediate banks
- Initiate online investigative requests (Canada accounts only)
- Safely and securely approve wire payments on the go from your mobile device
- Cross-border clients can create payments from both BMO Canada or BMO U.S. accounts

Simple and efficient management

- Quickly view and monitor all wire payment activity online or on your mobile device
- Create payments for same day value or scheduled up to 365 days in advance
- Delete or modify your wire payments until one day prior to the value date
- Track the history of your investigation requests (Canada accounts only)
- Receive alert notification for incoming and outgoing payments, wire templates or payments needing approval
- Make wire payments in over 20 foreign currencies using real-time rates

Access complete and customizable information

- Create custom reports based on user selected criteria
- Save reports as templates for your own use or to share with other users
- Receive full reporting details for incoming and outgoing payments
- Export and save data in a format that meets your needs

Security and control

- Set multiple limits for users including
 - Transaction dollar limits
 - Daily aggregate limits
 - Limits based on funding account
 - Template limits
- Choose from multiple approval settings and ability to set approvals differently for freeform vs. template wires
- Define functionality, account and report entitlements for each user
- Final payment approval requires multi-factor authentication

BMO Global Pay option

- Allows you to send payments under C\$100,000 (US\$100,000) to select countries [Minimum payment value of C\$25 (US\$25)]
- No fees will be deducted from the amount delivered to the beneficiary; your beneficiary will know the amount of funds to expect
- Up-Front conversion into destination currency also provides certainty around the exact amount of funds being delivered
- Provides the same security and control features that you are accustomed to for wires; all existing authentication and approval processes are applied
- Additional services are not required; access will be automatic for qualified payments
- You have the option to choose either BMO Global Pay service or send money via traditional wire
