## Terms and Conditions for BMO Smart Portfolio Promotional Offer

Get up to a \$1,000 cash bonus when you submit an application to open a new BMO Smart Portfolio (BSP) account between December 12, 2022 and October 31, 2024 and meet one of the three thresholds below:

- 1) Get a \$200 bonus when you deposit a minimum of \$5,000 to \$24,999.99 into your BSP account within 60 calendar days of account opening and hold for 90 calendar days.
