Objectives and Investment Policy

The fund aims to achieve a return similar to or better than that of the MSCI All Country World Index with lower volatility. The fund invests mainly in globally listed, low risk equities of companies, that at the time of purchase, have a minimum market worth of US\$100 million. The fund invests in companies that are believed to be undervalued. The fund is expected to be diversified.

Portfolio transaction costs are paid from the assets of the fund in addition to the charges set out in the "Charges" section below and may reduce its returns.

For temporary defensive purposes, the fund may invest, without limitation, in money market instruments.

The fund may invest in other types of eligible investments, as disclosed in the prospectus for the fund.

This share class does not intend to distribute net income and gains.

You may sell your shares on any day on which banks in Dublin and London are open for business by submitting an application to the administrator, State Street Fund Services (Ireland) Limited, by 11:00 a.m. (Irish time) on such day.

Recommendation: this fund may not be appropriate for investors who plan to withdraw their money in the short term.

Risk and Reward Profile

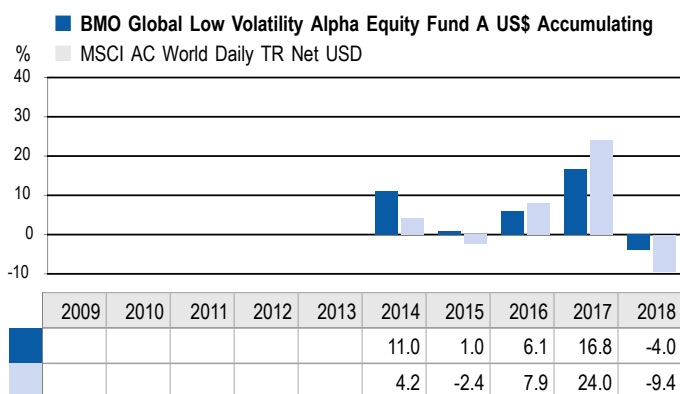
The entry and exit charge include a charge of up to 1.00% which may be retained by the fund to cover the cost of buying or selling securities by the fund and preserve the value of the fund.
